INFORMATION ON AUTOMATIC DEBIT FROM ACCOUNTS FOR UNLIMITED MONTHLY YOGA PROGRAM

1. The cost of the unlimited monthly yoga program is **\$65 per month**, which will be debited from your account on the 1st of each month (or that first banking day of the month).
2. If you sign-up after the first of the month, that month will be pro-rated based on the EFFECTIVE DATE, and that amount as well as the subsequent month's fee will be taken out on the 1st of the following month.
For example:
Sign-up date: March 15 – Prorated cost for that month - \$32.50
April 1st debit from account: \$32.50 (for March) + \$65 for April = \$97.50
3. Benefits that accompany this program:
 - a. Unlimited monthly yoga, regardless of class length
 - b. No worries about card expiration/keeping track of classes
 - c. 10% discount on retail items and workshop fees
 - e. Bring one guest FREE to studio per month
4. **If you want to cancel your membership in the program, you must give the Center a month's notice prior to canceling.** If you do not give adequate notice, one month's fee will be debited from you account. If you need to put your membership on hold, please contact Deb Lister, Director. By signing up for the program, you agree to the above requirements.
